SPECIAL REFERENDUM

ONE-CENT TRANSPORTATION SALES TAX

Vote Yes

Berkeley County Council has placed a referendum on the November 8, 2022 ballot to continue the one-cent sales transportation sales tax. The proposal is to continue the tax for 7 years and raise an estimated \$587 million, of which \$528 million will go towards transportation projects (90%) and \$59 million (10%) to Greenbelt projects. Berkeley has a strong track record of using their current penny sales tax dollars wisely and CTAR supports their referendum.
